I am very pleased to announce that the League of Women Voters of St. Louis and the St. Louis Post-Dispatch, Stltoday.com and the Suburban Journals have established collaborative relationship to have the April Voters Guide published as an insert in the newspaper the weekend before the election.

We are excited about this opportunity for the Guide to be in the hands of almost 300,000 Post Dispatch subscribers. We all see this as a win, win, for everyone, especially the voters. THE LEAGUE SUPPORTS PROPOSITION A

The League is supporting Proposition A on the April 6th ballot in St. Louis County.

Shall the County of St. Louis impose a countywide sales tax of one-half of one percent for the purpose of providing a source of funds for public transportation purpose including the restoration, operation and expansion of MetroLink, MetroBus, disabled and senior transportation, in addition to an existing sales tax of one-quarter of one percent for the same purpose?

The proposition requires a simple majority for passage. The sales tax is expected to raise \$75 million a year. In addition, a previously passed sales tax in the City of St. Louis will go into effect and produce \$8 million.

The St. Louis League has had a position of support of mass transit since 1969. The issue was restudied and the position updated in 1972 and 1980. The League has had a history of supporting mass transit, particularly of adequate funding to meet the transit needs of the area.

The League position states in part “support for a viable public mass transit system in order to save energy, preserve the environment and provide the public with a transportation alternative to the automobile”. The environmental benefits of mass transit have always been a major reason for supporting a good transit system but they are increasingly more important as we face the challenges of global climate change. According to the American Public Transportation Association “If an individual switches a 20-mile roundtrip commute to public transportation, his or her annual CO2 emissions will decrease by 4,800 pounds per year, equal to a 10 percent reduction in a two-car household’s carbon footprint”.

Transit is also a social policy issue. Our position goes on to state “A transit system must make employment, education, health care, and recreation opportunities available to the transit dependent population”. After a sales tax proposal similar to Proposition A failed in November 2008, the result was a one-third cut in transit services in Missouri. Metro was able to restore some of the services with emergency help from the State of Missouri and the Federal government. However, these emergency funds will run out in May. The impact of reduced service is particularly severe for those who rely on public transportation for access to health care and employment in difficult economic conditions. If Proposition A passes, the first priority for Metro will be restoration of the services that were cut in 2009. In addition, the funds will allow Metro to make improvements to all areas of transit services.

Metro has been working to develop short range (5 year), mid range (10 year) and long range (30 year) plans. These plans are being developed including public input that has taken place over the last several months in public meetings throughout the area and on line. Happenings in the Missouri Legislature

Death Penalty Moratorium

House Bill 1683 introduced by Rep. Deekin would establish a study commission on the death penalty. The commission shall report its findings and recommendations regarding the death penalty, including remedies for any deficiencies found by the commission, to the governor, members of the legislature, and the Missouri Supreme Court by January 2, 2013. No executions shall take place between the effective date of the bill and January 1, 2013. This bill has not been assigned to a committee yet.

Senate Bill 930, creates a death penalty commission and a moratorium on the death penalty until January 1, 2014. This bill has been second read and referred to the Judiciary and Civil and Criminal Jurisprudence Committee on February 11, 2010.

The League supports both these bills. If passed, we believe it will get us closer to abolishing the death penalty which is our ultimate goal. To receive current information on the status of these bills please call the League office to sign up for the bi-weekly legislative bulletin. In order for the League to be effective advocates, members must respond to calls for action which will indicate what you can do.

Taxes

SJR 29 and HJR 56 are two of the most horrendous pieces of tax legislature to come before the legislature. They are both proposed constitutional amendments, which if passed would require a vote of the people. They would eliminate the individual income and corporate income/franchise tax and all present sales tax and replace them with a new expanded sales tax.

The new statewide sales tax would include all purchases and services, including food, prescription drugs, medical care, child care and other services not presently taxed. Because the tax is intended to be tax neutral, it would raise the present sales tax to about 6.25 %. Estimates from other groups believe the sales tax estimate is faulty and that it would be as much as 11 %. The bill as it now stands has few exemptions, but each day more exemptions are being suggested. That would require an even higher sales tax. The League supports a balanced and progressive tax system to finance necessary governmental service which emphasizes equity and fair sharing of the tax burden. The League opposes taxing services. It believes corporations should assume a larger share of Missouri's tax burden. The League believes changes in tax law should be by statute, not a constitutional amendment. Therefore the League **strongly opposes this bill**.

What you can do

As of this writing, SJR 29 has been voted out of committee do pass. It is important that League members and friends write their Senators and tell them you strongly oppose this bill. It is a very regressive tax. It falls more heavily on those least able to pay, young families and low income individuals. It exempts corporations which the League believes should pay higher, not lower taxes. Senators who support this bill should be aware that many individuals oppose it. Senators who oppose this bill need to hear from their constituents so that they know that they have support to vote it down.

League members should write their letters and e-mails as individuals, not as members of the League. It is more effective that way. Only the president of the League or her designate may speak for the League. Please let the League office know any responses you receive. Please let me know that you have responded to this request for action.

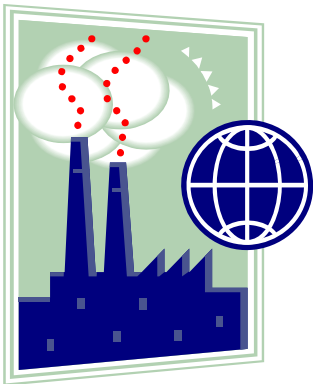


HEALTH CARE COMMITTEE
