From the President:

Dear Members and Friends,

A copy of the Declaration of Independence, printed in 1776, was recently on display in St. Louis as part of a national tour encouraging young people to vote. I was asked to say a few words about the League of Women Voters during a reception at the Missouri History Museum. It was a golden opportunity to lay a little League history on them about the suffragettes 70 year struggle to give women the right to vote.

This included a description of the “Walkless Talkless Parade” which occurred in St. Louis in 1916 during the Democratic National Convention. 7,000 women in long white dresses with yellow sashes and carrying yellow umbrellas lined both sides of the route to the convention hall. They had tape across their mouths signifying that they had no voice in voting. The delegates had to run this gauntlet to get to their meetings.

We will be commemorating this event on September 6, 2008 with our Yellow Umbrella Parade for Voters Rights at St. Louis University, Boileau Hall. (See page 10 for more information.) This is a fund-raiser for our Information Service so please support it. Rumor is rampant that at least one husband has offered to supply the tape.

Environmental Quality Committee

Last year as part of our focus on Global Climate Change, the Environmental Quality Committee worked with other organizations to encourage the mayors of communities throughout the county to sign on to the Clean Cities Initiative. We will continue to monitor what communities are doing to promote energy conservation and sustainability.

However, there are many things we can do as individuals which will make significant progress toward improving our environment and conserving natural resources. The EQ Committee will focus on one suggestion in each *In League Reporter*.

Compact fluorescent light bulbs (CFL) are widely available and come in an increasing number of designs to meet our lighting needs. According to the Environmental Protection Agency and Department of Energy website, www.energystar.gov, "If every American home replaced just one light bulb with an ENERGY STAR qualified bulb, we would save enough energy to light more than 3 million homes for a year, more than \$600 million in annual energy costs, and prevent greenhouse gases equivalent to the emissions of more than 800,000 cars." That is impressive. The site provides extensive information on the available types of bulbs and fixtures. CFLs do contain a small amount of mercury. However, advances in technology are reducing the amount of mercury and since the generation of electricity is the main source of mercury in the environment, the benefit in electric savings outweighs the amount of mercury in the bulbs. You do have to exercise caution in handling the cleanup if a bulb should break. Guidance is provided at the Energy Star website. Used bulbs should not be put in trash or recycling bins. They should be taken to an appropriate center for recycling. Home Depot stores take the bulbs as does Lens Masters, 11309 Midland Blvd. (at Lindbergh) and D-Cal, 2909 Rock Hill Industrial Court.

The International Relations Committee

The International Relations Committee will resume its regular monthly meetings on Friday, September 12, at 10:00 a.m. at the St. Louis County Library Headquarters. The group is open to all Saint Louis League members. You will be most welcome. Judith Smart is the Committee Chair.

This year's topic for study is Pakistan. In keeping with this, brief high-lights follow from a book by Yasmin Khan, "The Great Partition, the Making of India and Pakistan."

Yasmin Khan currently teaches politics in the Faculty of History and Social Sciences at Royal Holloway, University of London. She has lived in Delhi, and has links to both India and Pakistan.

This book is about the end of the British Indian Empire, and the division of India into the two states of India and Pakistan from the South Asian landmass with growing antipathy toward one another. The book aims to show how disorderly and tumultuous the partitioning was, and how both states felt threatened because of changes, and about ambiguous meanings of Pakistan and India to those who were not sure of their status re: the government.

There appears to have been no general and widespread preparation of many of the people for the Partition. Those people who had access to radios and news pamphlets learned of the upcoming event. People who lived out in the countryside had no knowledge of the change until many months later. Butchery of many and forced relocation in the summer months may have been the first news for peasants and sharecroppers.

Many people and communities had unclear allegiances to India or Pakistan. Borders were changed and families were separated. Travelling was restricted and family separations painful. Refugees fleeing from harm or in confusion, flocked by the thousands to Pakistan, to such an extent that the very existence of Pakistan was endangered.

Space is necessarily too limited to further discuss Yasmin Khan's book, which I recommend for getting a feel of the development of Pakistan and India, and circumstances in determination of their borders.

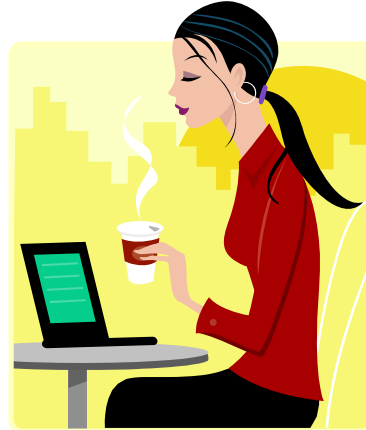

LWVUS 2008 National Convention Postscript

A postscript to the reports you have received from the LWV-STL delegates on their activities at the League's national convention involves the roll call of states. Those of you who have attended national conventions know that each state's president/representative gets one minute to highlight that state's accomplishments since the last convention. A monumental task if there ever were one. The four of us from STL agreed that one of the best reports this year was from the PA president, Andrea Mulrine. She read an editorial from a PA newspaper which had a wonderful description of Leaguers as governmental watchdogs and the lawsuit they are involved in. An abbreviated form of the editorial follows:

The commonly held image of the League of Women Voters — and please forgive us for any unintended ageism or sexism here — seems to have been that of a group of genteel elderly ladies, properly sipping tea while stuffing candidate questionnaires into envelopes and politely urging their neighbors to do their patriotic duty. Granny in the old Warner Bros. “Tweety Bird” cartoons with, perhaps, a neatly crocheted flag pin on her cardigan, might have been a typical member.

If that were ever accurate, it certainly isn't today. Think Granny on steroids. Think hatchet-wielding Carrie Nation breaking down the doors, not of Prohibition-era speakeasies seeking temperance, but of smoke-filled rooms in the state capital, demanding political and governmental reform.

This is the new League of Women Voters, energized — as well it should be — by outrage over the General Assembly's infamous self granted pay raise of '05 and other nefarious activities. Its latest mailing to a political figure is not a question about Social Security reform, but a lawsuit, and it was filed against no less a figure than Ralph J. Cappy, former chief justice of the Pennsylvania Supreme Court.... But, acquiescing, perhaps, to the credibility and moral authority the league possesses, Cappy issued his statement immediately after news of the suit hit the streets. Saloon keepers, after all, ignored Carrie Nation at their own risk. “I do not understand why a respected organization such as the League of Women Voters would associate itself with this irresponsible lawsuit, especially since the charges consist of falsehoods, speculation and innuendo,” Cappy said in his mass-circulated response.

But the league is sticking to its ax. Members aren't hallucinating — there was nothing strange in the sugar cubes they stirred into their tea — nor did a little birdie tell them about the alleged shady dealing. They heard about it, according to the 17- page document filed in federal court in Harrisburg, from an unnamed state senator....

If the charges contained in the league's lawsuit are true, state government in Harrisburg — the most corrupt in the United States, according to Tim Potts of the reform-advocacy group Democracy Rising Pennsylvania — is even more corrupt than we thought, and who would have thought that to be possible?... Misplaced outrage or fact-based moral crusade? It will be up to the courts to decide. Thankfully and fortuitously, it will be the federal, not state appellate courts, that will make the final determination.

Carrie A. Nation said she was called to save America from a drunkard's fate. Maybe — just maybe — her modern-day counterparts in the League of Women Voters can reform Harrisburg.

Gentle ladies, sharpen your hatchets.

YELLOW UMBRELLA EVENT SEPTEMBER 6 HONORS SUFFRAGISTS

The League of Women Voters of St. Louis will observe the 92nd anniversary of a landmark protest in the women's suffrage movement with a parade and rally on Saturday, Sept. 6, at Boileau Hall, Vandeventer and Laclede avenues, on the St. Louis University campus.

The event will celebrate the "Walkless, Talkless Parade of 1916," when 7,000 St. Louis women, wearing white dresses with yellow sashes and carrying yellow umbrellas, lined the streets leading to the Democratic National Convention in St. Louis and stood silent as delegates walked past them to the hall – silent, because the women had their mouths taped shut. It was a turning point in women's struggle to gain the vote, which finally came in 1919 when Congress passed the Nineteenth Amendment granting women the right to vote.

Known as the Yellow Umbrella Event, the Sept. 6 program will feature half-mile and full-mile parades at 10:30 a. m., followed by an 11:30 a. m. rally with talks by St. Louis County Executive Charlie Dooley; Vivian Eveloff, founder and director of the Sue Shear Institute for Women in Public Life, and Sandy Diamond, executive director of Kids Voting Missouri, a senior high school and college student organization on some 40 area campuses. The panel will focus on the value of having every eligible American vote in every election.

The League will also offer voter registration at the event.

The program is sponsored by The Ben & Jerry's Foundation and The League of Women Voters Information Service. Proceeds benefit voter service projects of Kids Voting Missouri and the League's Information Service.

Participants can pre-register for the Yellow Umbrella event by Sept. 3 for \$25, or register at the program for \$30, starting at 9 a.m. Advance and on-site student registration is \$10 with a student identification card. Businesses can register up to 10 participants for \$350. Advance registration forms are available from www.lwvstlorg or by calling 314-961-6869. Registrations should be mailed to League of Women Voters Information Service, 8706 Manchester Rd., Suite 104, St. Louis, MO 63144. Checks should be made payable to LWVIS.
